MiCAR Article 88 is in force. The obligation to disclose inside information - publicly, verifiably, and on time - applies to every CASP, exchange, token issuer, and service provider with access to that information.

What DAAvern Does

One submission. One complete, permanent compliance record.

1 Create a verifiable record

Cryptographically timestamped and anchored on-chain - tamper-resistant, court-admissible, independently verifiable.

2 Publish across your channels

Website and social media, verified link-by-link. Every published URL captured and added to your compliance record.

3 Distribute through DAAvern's network

Journalist and media network covering digital asset markets. Automatic stakeholder distribution list notifications.

4 Notify the relevant authorities

Optional: formal notification to NCAs and ESMA. Full supervisory defensibility.
